



Competition „Aeroaccess’ Aruba goes Aruba”

Conditions of Participation

## I. General

### 1. Legal Basis

This contest is held under German laws. Legal process is excluded.

### 2. Organizer

Aeroaccess GmbH, Klenzestr. 1, 85737 Ismaning, Germany

### 3. Who can participate?

Every employee of companies, which have received Aruba equipment from aeroaccess GmbH, can participate. The participant must be of age 18 or older.

Employees of aeroaccess GmbH and their relatives are excluded from participation.

(Former) employees of HPE/Aruba Networks and their relatives are likewise excluded.

### 4. Fee

The participation in the contest is free.

### 5. Participation Period

The competition consists of two parts, the main competition and the monthly competition.

The main competition starts January 1st 2018 and ends June 30th 2018, 23:59 Central European Summer Time.

The monthly competition consists of a question, that changes on the 1<sup>st</sup> of every month and which can be answered until 23:59 Central European (Summer) Time of the very month.

### 6. Participation Process

For the main part, every participant is entitled to hand in one guess per week. This means that every participant can hand in up to 26 guesses, of which everyone is valid for the drawing of the winner.

For the monthly part, every participant can hand in just one answer.

### 7. Lottery Question for the Main Part

The question is as follows:

*“How many Aruba Access Points will Aeroaccess GmbH have delivered since its founding until 30<sup>th</sup> June 2018 23:59 Central European Summer Time?”*

Delivery means the hardware has left the office premises of aeroaccess GmbH in Ismaning.

This includes:

- (a) Access Points, which have been delivered since the founding of Aeroaccess GmbH until 31<sup>st</sup> December 2017,
- (b) Access Points, which will have been delivered from 1<sup>st</sup> January 2018 until 30<sup>th</sup> June 2018, and
- (c) Access Points, which will have been delivered to costumers via RMA exchange since founding of Aeroaccess GmbH until 30<sup>th</sup> June 2018.

The question for the monthly lottery will be published on the website <http://www.aeroaccess.de/en/competition>.

## **8. How to participate?**

Participants can hand in their guesses for both parts of the competition via aeroaccess homepage, [www.aeroaccess.de/en/competition](http://www.aeroaccess.de/en/competition).

## **9. Necessary Information to be handed in for Participation**

The participant has to hand in his email-address, his guess and a pseudonym. The latter will be used for the weekly publishing of the guesses to guarantee a minimum level of privacy protection, but to carry out the lottery as transparent as possible (see also point II. Transparency).

Every participant shall use only one email-address during the whole competition.

## **10. Prize**

The prize of the main competition will be a 14-day cruise trip to the Caribbean, including the island of Aruba for two people with minimum value €5,000. This includes the ship cabin, All-Inclusive catering, flights, and arrival / departure to / from leaving port and in Germany arising taxes.

Depending on the amount of participating people, the value of the trip can rise to €10,000 maximum, which can result in higher cabin category, better arrival / departure conditions, aboard credit, etc.

There will be only one first prize. Second and third as well as other prizes are not to be expected.

Necessary visas are not included.

The prize cannot be transferred to someone else.

The prizes for the monthly competition will be published on the website [www.aeroaccess.de/en/competition](http://www.aeroaccess.de/en/competition).

## **11. Lottery Tickets and Prize**

The guesses of the participants will be seen as lottery tickets. Every ticket has a value of €2,50. If there are 2.000 or less guesses, the first prize will have the minimum value of €5.000.

If there are more than 2.000 guesses, the value of the cruise trip will rise according to €2,50 per each additional ticket.

On every ticket will be paid taxes.

## **12. Who will win the Prize?**

a)

The person with the correct answer will win the prize. This is valid for the main and the monthly competition.

b)

If nobody guessed the correct answer in the main competition, the person, whose guess is closest to the correct answer will win. In this case it does not matter if the guessed answer is lower or higher than the correct answer. This is valid for the main and the monthly competition.

c)

If there is more than one person with the correct or closest guess, the winner will be decided by drawing lots. This is valid for the main and the monthly competition.

## **13. Special Regulation**

In case of force majeure (winner won't get visa etc.), where the winner is unable to start the cruise to the Caribbean, the cruise can be changed to another destination.

## **14. Date of Drawing of the Winners**

The winner of the main competition will be drawn on the first weekday of July 2018 (i.e. 2<sup>nd</sup> July 2018).

The winner of the monthly competitions will be drawn and published on the first weekday of the following month.

## **15. Notification of the Winners**

a)

The winners of either parts of the competition will be informed by aeroaccess GmbH about their win via their provided email immediately after the drawing. The winners have to answer via email or telephone.

b)

Should the winners miss to respond within 30 days after the drawing, their claims to the prizes will expire. In this case, the participants described under section 12. c) will replace them.

## **16. Other**

The purchase of Aruba hardware, software, service or aeroaccess GmbH service does not have positive influence for the participants on the outcome of the competition.

## **II. Transparency**

Regarding the main competition, aeroaccess GmbH guarantees full transparency of this contest. For this purpose, there will be a weekly update about the valid guesses received by aeroaccess GmbH. These will be published together with the pseudonyms used by the participants. Consequently, the participants will see their own entries.

In addition, the range of possible answers between 1 to 250.000 will be reduced by 2.000 on a weekly basis. This reduction can occur at both ends of the range. In this way, the participants shall be able to hand in guesses which are closer to the correct answer.

## **III. Privacy Protection**

### **1. Verification of Identity**

With handing in guesses the participant acknowledges that in case of a win of one part of the competition, aeroaccess GmbH checks the identity and entitlement to a win. A check of the identity of participants, who are not entitled to a win, is not planned.

### **2. Personal Data**

The winner of the main competition acknowledges that he will have to provide aeroaccess GmbH with his own and the personal data of the second travel guest as far as they are necessary for the booking of the cruise trip.

### **3. Transmission to Third Parties**

a)

A transmission of the personal data of the winner and his travel guest through aeroaccess GmbH only occurs towards the tour operator for the purpose of applying the winner and his travel guest for the cruise trip.

b)

A further transmission of the personal data of the second travel guest is impossible.

c)

A further transmission of the personal data of the winner apart from 3. a) and 3. b) is impossible.

#### **4. Publication of the Winners**

a)

The winners acknowledge that their win will be published only with their pseudonym via the homepage of aeroaccess GmbH ([www.aeroaccess.de/en](http://www.aeroaccess.de/en)) as well as via its social network accounts on [www.xing.de](http://www.xing.de) (mainly German speaking), [www.linkedin.com](http://www.linkedin.com) (mainly English speaking) and last but not least, [www.twitter.de](http://www.twitter.de).

b)

The publication of the winners will only be made via their pseudonyms.
